The M&E Officer will work closely with the Programs Manager, the Programs Committee, and partners to ensure that data is accurately collected and utilized for informed decision-making.

- Bachelor's or Master's degree in a relevant field (e.g., International Development, Public Health, Social Sciences) or equivalent experience with some higher education.
- Proven experience in M&E, preferably in the non-profit sector.

- Proficiency in data analysis tools such as Excel, or statistical software.

- Excellent communication and reportwriting skills.
- Ability to work independently and remotely.
- Knowledge of relevant data collection and management tools and software.
- Fluent in Dari, and Pashto; good English.
- Ability to travel to Kabul.
